A Message From the President

"Now this is not the end. It is not even the beginning of the end. But it is, perhaps, the end of the beginning." Churchill and the world were facing a far graver situation in 1942 than we find ourselves in. But the belief that brotherhood, honor and determination allows just causes to succeed is abundant in both cases.

The new school year is well underway, and Ann Arbor is bustling like we all remember it. The Sigma Chi house is also full and active with our new tenants. The house looks great after a summer of front-porch repair, lawn maintenance, minor landscaping and cleanup. We signed a four-year lease with the Sigma Phi Epsilon fraternity this past summer, and they have 31 undergraduates living in. They are excited about the house and the location. They reported a successful fall rush with 18 pledges on board. I would not normally expect any Sigma Chi alumni to be excited about the state of affairs of the Sig Eps but, after the events of last fall, having a full, rent-paying, undergraduate chapter is a significant step toward the rebuilding of the Theta Theta Chapter.

The house corporation remains focused and engaged, and is meeting monthly in Ann Arbor. Below are a few of the things we accomplished since the loss of the undergraduate chapter last October. We:

- secured property and liability insurance after Risk Management terminated coverage.
- maintained the property with the assistance of our property manager, Fraternity Rho Inc.
- passed our city and insurance inspections.
- attracted and signed Sigma Phi Epsilon fraternity to a four-year lease (August 2004 to August 2008).
- secured a \$100,000 equity line to provide cash flow until our tenants moved in this fall.

- completed our pre-move-in upgrades (painting, landscaping, porch repair, etc.).
- converted our insurance from unoccupied to occupied coverage.
- secured new directors and officers coverage.
- collected and stored the charter, regalia and chapter artifacts.

These tasks are representative of the two most important objectives of your house corporation board: 1) stewardship and preservation of the chapter house at 548 South State, and 2) the recolonization of the Theta Theta Chapter in four years. All of our focus and activities shall be toward these aims. The return of Theta Theta to the University of Michigan is a noble cause, and a half-hearted attempt would be an affront to the more than 1,000 Theta Theta alumni who gave luster to the badge of Sigma Chi.

Our financial status is stable and sustainable, but the debt load is significant. The loss of rent for six of the eight months last year put a strain on our finances. As of October, the house corporation had \$22,000 cash, \$62,000 equity-line debt and a \$712,000 mortgage. The centerpiece of our new four-year financial plan we devised is our tenant lease that includes yearly rent increases. We shall utilize our equity line to meet our obligations for the next 18 months, and then we will pay off the equity line and pay down debt with the positive cash flow for the remainder of the lease term.

The blueprint we envision for the future involves participation and sacrifice from alumni in concert with the house corporation board. The Theta Theta recolonization is an opportunity to infuse the undergraduate chapter with the values that we know create leaders of men and brothers for life. Many chapters, including (recently) Northwestern, have successfully emerged from a loss of charter. We will be reaching out to the alumni, alumni chapters and national

Frequently ASKED Questions

Over the last several months we have fielded many questions from our alumni. Below we have addressed some of the most common concerns. In addition to the questions and answers below we will be posting additional news on our Web site at www.thetatheta.com as we receive your feedback.

Who is occupying the house?

The Sig Eps (Sigma Phi Epsilon) have signed a four-year lease to occupy the chapter house. They have a strong undergraduate chapter on campus and a committed and involved alumni board.

What are the terms of the lease?

The four-year lease payments increase over time from a small shortfall during the first year to an eventual cash-flow benefit during the final years. In addition to covering our expenses during this time we will also be reducing the principal balances of our existing loans by making our scheduled payments.

Am I welcome at the house?

We have enjoyed a positive relationship with the Sig Ep undergraduate chapter and alumni board and they have been very accommodating to our members who have already visited the chapter house this fall. We expect this opportunity to continue while we also balance the nature of our relationship that provides their chapter and alumni with the full use of our house during the term of the lease.

What is the status of the renovation project?

Our renovation project included making critical updates to the infrastructure of the chapter house. The primary priorities were the heating, plumbing, electrical and fire suppression systems, asbestos abatement, and the upstairs windows. We still have many items on our "to do" list, and the most common area we hear about is the highly visible first floor that needs new windows and improved aesthetic appeal. The renovation work we were able to complete was critical in allowing us to attract a tenant and to preserve the chapter house for future generations. We have successfully passed all code and safety inspections.

Are there plans to recolonize?

Yes. Our goal for recolonizing is to have Sigma Chis ready to move back into our chapter house when the Sig Ep lease is complete. The process will include petitioning our national organization for reinstatement and a commitment from our alumni to support the process.

What course of action is the house corporation taking to recolonize a chapter whose members value the traditions and ideals of Sigma Chi?

There are many important issues for our members to resolve before a new Theta Theta Chapter can be reinstated with a great opportunity to be successful. Our goal will continue to be to provide an atmosphere and experience that cultivates young men and produces leaders and positive members of our brotherhood. We will be considering many options including a dry house, a live-in adult advisor, alumni big brother and mentoring programs, and increased alumni involvement in the rush, ritual, and indoctrination processes. We will be reviewing our methods for recruiting great candidates for membership and redefining the role of our chapter on campus.

What is the state of the Greek system at Michigan?

In addition to the troubles our chapter experienced, there are other fraternities and sororities that have suffered similar

problems. The university and representatives from the Greek system have been meeting to work on solutions that will allow the Greek system to continue to satisfy an important roll on campus and provide leadership, enrichment and housing opportunities for undergraduates. As both sides work together toward preserving the positives of our system, we are optimistic we will be recolonizing our chapter into a system that will have addressed many of the issues that were a threat to our existence.

What is the state of our house corporation?

Our house corporation meets on a monthly basis in Ann Arbor. In addition to checking on and maintaining the physical condition of the house, we are meeting our financial obligations and working toward recolonizing our chapter. While we have satisfied one of our major issues by securing a tenant for the next four years, we still have many projects to complete and a lot of work to do before we can recolonize. How can I help?

First of all we ask you to continue to participate in Theta Theta by providing alumni news to be shared in our publication. Our alumni are over 1,100 strong, and it is important that we continue to keep the bond alive.

Second, we continue to need your financial support. The current debt load on the chapter house is over \$700,000. We have secured a line of credit to facilitate some of our cashflow requirements; however, we must pay down this debt and reduce the monthly loan expenses in order to be in a position to successfully recolonize. Your donations also pay for publications such as this one and allow us to continue to make required improvements to the chapter house.

Finally, we need your participation in recolonizing the chapter. We will be assembling a committee this coming spring to formulate our game plan for a successful recolonization. This will include increased alumni participation across the country identifying and recruiting quality candidates, an alumni big brother and mentoring program, and established criteria and high standards for membership in our fraternity.

If I contribute funds now, how will they be used?

Your donations continue to be required to pay for alumni communications, maintenance and improvements to the chapter house, and to satisfy loan obligations. Unfortunately, contributions to the chapter are not tax deductible.

How can I leave a legacy to help sustain the chapter?

Continuing the current alumni support model — which depends on one or two brothers carrying most of the load as advisers, landlords and business agents — is unrealistic. This would only guarantee the burnout of the volunteer brothers and our jumping from crisis to crisis.

The short and simple of it is this: We, as alumni, must adjust our involvement to meet the current needs of the chapter. Toward this end, we are asking each and every one of you to please consider joining the alumni board. We are looking for a dedicated group of five to 10 individuals to help run the board's vital functions and to ensure the continuing health of the chapter.

One of our goals is to increase involvement so that all of the undergraduate officers have an ongoing alumni contact or mentor. The board members will support the undergraduate officers in the execution of their duties, help them develop procedural mechanisms to work more efficiently, ensure the smooth transition of undergraduate officers and incorporate all of our activities into a solid and ongoing fraternity education program. As we think about building and maintaining a strong, progressive chapter, the quality of our team is just as critical. We are appealing to you — our brothers — to play an integral role in the growth and sustenance of the chapter. You can make a difference. Most definitely, you have many talents from which our undergraduate brothers would greatly benefit. Please step up and take your place on the board.


